I am writing to let you know that the latest version of the draft Local Plan has now been published. This follows consultation on the 'Preferred Options' version of the Plan during the summer and autumn of 2018. I would like to pass on my thanks to those who provided comments.

This document - 'the Pre-Submission Draft' - is the version of the Local Plan which the National Park Authority proposes to submit to the Secretary of State for independent examination. Prior to this, we are asking for any comments on the plan over a six week period, running from **Wednesday 10 April 2019 to Friday 24 May 2019**, so that these can be submitted to the Secretary of State alongside the draft Plan.

Any representations should relate to the tests of soundness and/or its legal compliance. A representation form, accompanied by background notes explaining the process of making representation and the tests of soundness is available to assist in this process. The form is available to download from the Authority's website <http://www.northyorkmoors.org.uk/localplan> or alternatively if you would like a hard copy sending out to you please let us know.
