Stream	Slips, trips, falls Getting wet Drowning	Group members	<p>The National Park Activity Leader will:</p> <p>Check footwear before departure. Group leaders advised in advance that pupils will require wellies. Any pupils without wellies to be provided with wellies from kit store where possible.</p> <p>Assess conditions on arrival at the site and not allow anybody to enter the water unless the depth is below the height of the pupils' wellies.</p> <p>Manage the session so that pupils are either sitting on the bank being taught as one large group or working in smaller groups of up to 6 pupils, each of which can be easily watched and supervised by an adult.</p> <p>Allocate each small group a section of stream to work in, with good access and egress and with markers at each end of the work site. Instruct pupils not to go beyond markers. Allocate adults to supervise one or two specific groups so that each small group can be supervised by an adult.</p> <p>Warn of danger of slipping on rocks. Undercut river banks	Falling	Group members	Point out feature, warn of danger, leader to be familiar with site and ensure group members do not stand on top of undercut banks.	(1 x 2) 2 MEDIUM	
Leptospirosis (Weil's disease)	Infection	Group members	<p>Any individuals with cuts, grazes on hands to wear hypo allergenic plasters and nitrile gloves.</p> <p>Direct group to wash hands immediately after activity. Low branches on river banks	Cuts, grazes, injuries to head / eyes.	Group members	Warn of hazard. Avoid leading group / working under low branches.	(2 x 2) 4 MEDIUM	
Turning over rocks	Trapping fingers, injuries to feet.	Group members	Demonstrate the size of the largest rock (appropriate to the pupils' age / ability) which pupils are allowed to turn over/pick up. E.g. do not attempt to move rocks larger than a football.	(2 x 1) 2 MEDIUM	
Field study equipment e.g. tape measures, metre rulers, hand nets etc.	Cuts, grazes, bruises from incorrect use	Group members	Demonstrate correct use of equipment before starting session and supervise closely. See generic risk assessment for field studies.	(1 x 1) 1 LOW
