Group leaders advised in advance that pupils will require wellies. Any pupils without wellies to be provided with wellies from kit store where possible. Assess conditions on arrival at the site and not allow anybody to enter the water unless the depth is below the height of the pupils' wellies. Manage the session so that pupils are either sitting on the bank being taught as one large group or working in smaller groups of up to 6 pupils, each of which can be easily watched and supervised by an adult. Allocate each small group a section of stream to work in, with good access and egress and with markers at each end of the work site. Instruct pupils not to go beyond markers. Allocate adults to supervise one or two specific groups so that each small group can be supervised by an adult. Warn of danger of slipping on rocks. Direct pupils to work in slowest flowing sections.
