Town and Country Planning (Local Planning) (England) Regulations 2012 – Regulation 19

Notice to hereby given, in accordance with Regulation 19 of the Town and Country Planning (Local Development) (England) Regulations 2012 that the North York Moors National Park Authority has produced the North York Moors Local Plan Regulation 19 Pre-Submission Draft which covers the whole area of the North York Moors National Park.

1) Title of Document:

The North York Moors National Park Authority Pre-Submission Draft Local Plan – April 2019.

2) Subject Matter

The North York Moors National Park Authority Pre-Submission Draft Local Plan sets out a vision, objectives and overall spatial strategy for the National Park from 2016 to 2035. The policies in the Plan will be used alongside The Helmsley Local Plan, The Whitby Business Park Area Action Plan and the forthcoming Minerals and Waste Joint Plan to make decisions on planning applications within the National Park.

3) Period within which representations may be made

Representations are invited on the North York Moors Pre-Submission Draft Local Plan for a period of 6 weeks which begins on Wednesday 10 April 2019 and ends at 5.00pm on Friday 24 May 2019.

Representations received after this time will not be accepted. Only representations received within this period have a statutory right to be considered by the Inspector at the Examination.
